

TERMS AND CONDITIONS

1. Access to Personal Information

ITI Inc. (“**ITI**”) commits to respect the private life of its users and customers. This article explains how the information tied to the online platform, SwapCard and Digicast (the “**Platform**”) used by ITI for its event le Sommet des experts en TI (the “**SITI**”) will be collected and distributed.

Your IP address may be used to collect general location information. This information may be used to simplify request processing, answer questions, improve the quality of our services, or to provide you with content adapted to your needs. ITI may, without prior notice, share this information with its business partners, business representatives or distributors, so that said persons can use this information on behalf of ITI. By using the Platform, you consent to said general location information being collected, used and shared.

ITI may use the collected information to send you a newsletter containing information about new products and services. Platform users may unsubscribe from the mailing list at any time. Apart from as stipulated in the previous paragraph, your information will not be sold or otherwise transferred to a third party without your explicit consent. ITI will not be held responsible for any direct or indirect damages resulting from the application of the terms and conditions for the use of the Platform established herein.

We may be required to disclose your personal information in order to apply the Partnership Agreement entered into for the SITI, to satisfy legal requirements, to address claims relating to the breach of a law or of a third party’s rights, including intellectual property rights, or for the public’s safety. This information will be disclosed in accordance with applicable laws and regulations.

Agora Opus3, mandated by ITI Inc. to act as support to the organizing committee as part of the organization of SITI, adopted the principles of the General Data Protection Regulation (GDPR) of the European Union with regard to the transparency of the processing of personal data.

Acting as a third party, Agora Opus3 will govern the collection and processing of personal data of SITI participants in compliance with the GDPR.

We will provide interested individuals access to the personal information we hold about them. Interested individuals can access their personal information by contacting aa.mauffette@iti.ca. If the individual concerned can demonstrate that the information we hold is incorrect or incomplete, we will make the required changes.

2. Intellectual Property

ITI and its partners hold the copyrights and intellectual property rights, whether registered or not, associated with the content and design of the Platform and of the SITI, as well as any material and content that may be shared with you via email or any other method (hereinafter referred to as the “**Content**”). Consequently, you are prohibited from:

- a) Extracting by permanently or temporarily transferring all or a qualitative or quantitative substantial portion of the Content onto another medium, by any means and in any form; and
- b) Reusing, by making available to the public or a third party, all or a qualitative or quantitative substantial portion of the Content, in any format, including via a hyperlink.

The brand names, logos, corporate names, acronyms and trade names of ITI and its partners mentioned on the Platform constitute distinctive signs and cannot be used without the express and prior authorization of their owner. You must not modify, copy, reproduce, reprint, share or distribute the intellectual property of ITI and its partners or any other Content.

3. Personal Information and Confidentiality Policy

To participate in the SITI and to access the Platform, you must first complete a registration form (hereinafter referred to as the “**Form**”) containing a number of personal details. Details which must obligatorily be provided in the Form are identified with an asterisk.

The personal information collected through the Form will be used by ITI for the purposes of organizing the SITI, managing exhibitor relations, marketing, promoting and prospecting, as permitted by law.

The information collected via scanner is intended for ITI and may be shared, in particular, to the SITI exhibitors whose booths you visit.

By using the Platform, you expressly consent to the sharing of personal information as described in this article.

ITI and its partners will also collect some standard data via the Platform in the form of cookies, for example your IP address, browser type, operating system, access time, etc. This information will be used for statistical purposes and to facilitate the use of the Platform. You may refuse or deactivate the cookies if your browser has this option. To do so, please consult your browser’s settings. However, if you do deactivate or refuse the cookies, you may have difficulty navigating the Platform and using some of its functions.

Please note that by registering for the event, you are authorizing the circulation of photos and

videos taken during the SITI.

4. Limitation of Liability

The Platform's content may contain some errors or inaccuracies. ITI reserves the right to correct these errors and to make improvements to the Platform at any time, and cannot be held responsible for any losses or damages caused by said errors or inaccuracies. ITI cannot guarantee uninterrupted access to the Platform, that the Platform be as powerful as you expect, that the integrated functions are without fault, or that the Platform or the server hosting the Platform are permanently devoid of any viruses or other malicious computer programs.

5. Acceptance of this Agreement

By registering for the SITI, you hereby acknowledge having read and understood the conditions of use established in these Terms and Conditions.

These Terms and Conditions constitute an agreement governed by the laws of the Province of Quebec, regardless of the principles of conflict of applicable laws.

If ITI fails to utilize any of its rights established herein, said failure will not constitute the waiving or modifying of ITI's rights.

The Platform contains or may contain links to other websites. ITI has no control over third-party websites or their content. The inclusion of links to third party websites on the Platform in no way indicates that ITI approves of or endorses their content, policies, or conditions of use. Users who access these websites do so at their own risk.
